What It Is

The ERC is a tax return that businesses can claim on qualified wages, including certain health insurance costs. Businesses that endured covid-related disruptions or a decline in gross receipts can still claim tens of thousands of dollars in tax relief – up to **\$26,000 per employee**, paid to you in cash.
